(continued from preceeding page) continued into Coronado and North Island. Customers in recent years were the Amphibious Base and the North Island Naval Air Station. The last civilian customer, the Hotel del Coronado, received an occasional tank car of fuel oil on a short spur that crossed Glorietta Boulevard until about ten years age. In recent years activity was limited to two trains weekly.

End of active trackage of the Coronado Belt Line is now at the salt works just south of Chula Vista.
